Dear Kristian,

I write to confirm the agreement that has been reached between you & me in relation to the recording & publishing & video activities of myself (pka The Orb). By signing the attached copy of this letter you are agreeing to be bound by all of the points contained herein & I therefore advise you to discuss it fully with a lawyer who is experienced in recording and publishing and film industry contracts.

1. By an agreement of the 16th February 1990, I entered into a recording agreement with WAU! Mr Modo Records Limited upon the terms & conditions more particularly contained therein (see attached 1st Appendix). On the 14th of August 1990, WAU! Mr Modo entered into a worldwide licensing agreement with Big Life Records Limited upon the terms & conditions more particularly contained therein (see attached 2nd Appendix).

2. By a letter of the 1st day of April 1990 I extended the agreement for the period of time as is more particularly set out in such letter (see attached 3rd Appendix). *AM recording*

3. By an agreement of the 14th day of August 1991 I & Adam Morris together trading as Orb Music entered into an administration agreement relating to my publishing interests in my compositions with Big Life Music Limited (see attached 4th Appendix).

4. By a letter of the day of 199 WAU! Mr Modo entered into an agreement with Big Life Pictures Limited relating to the sale of video films relating to my group "The Orb" (see Attached 5th Appendix).

I have requested and you have indicated your willingness to join with me in the activities of "The Orb" and you agree to do so on the terms set out herein (including also the terms set out in the Appendices to this letter as nominated above). For the purposes of this agreement it is agreed that you have been an active member of The Orb since 1st of March 1991. Further it is agreed and understood that by signing this agreement, all rights to the use of the name "The Orb" in relation to the recording, publishing & video activities of the group remain the sole and exclusive ^{property of} ~~right~~ of myself (Alex Paterson) and you hereby agree that if at any time in the future we should decide to terminate our working relationship, all rights to use the name "The Orb" shall remain with me.

6. In consideration of you signing this agreement I hereby agree to share with you equally all income due to me arising from the said agreements with Big Life Records Limited and Big Life Music Limited and Big Life Pictures Limited in connection with all recordings and compositions and videos relating to The Orb that you perform on or co-write. In consideration of my agreement you agree to be bound exclusively to Big Life Records Limited and Big Life Music Limited and Big Life Pictures Limited in so far as you perform or compose for "The Orb".

7. You agree to sign any inducement letter reasonably required by Big Life Records Limited or Big Life Music Limited or Big Life Pictures Limited to give full force and effect to these agreements (see attached 6th Appendix). Subject to your right to seek independent legal advice. ^{AM}

8. For the avoidance of doubt I hereby confirm that any previous agreements made between us (relating to the songs entitled "Earth (Gaia)" & "Towers Of Dub") are hereby superseded and replaced by the terms and conditions outlined in this letter and its appendices.

Please indicate your agreement by signing the attached copy and returning to me.
